The Researcher Test was held on February 29, 2024, the Preliminary Rounds were held on March 1<sup>st</sup> and 2<sup>nd</sup>, 2024, Quarter Finals were held on March 3<sup>rd</sup>, 2024 and Semi Finals and Finals were held offline on March 19, 2024. Senior Academicians from across India including Central Universities and NLUs along with Advocates were invited as Judges for the Preliminary Rounds, Dr. Ganasen K. Associate Professor from VIT School of Law, Dr. Anita Vinod, Associate Professor from Government Law College, Karnataka, and Mr Tariqaziz Choudhury Advocate Gauhati High Court were invited as Judges for Quarter Finals, Advocate S.C.
