A: For Quiz Competition

- 3. There will be a written preliminary round from which six teams will go to the main final round.
- 4. All the questions will be centered around the Constitution of India, its history and governance.
- 5. Quiz master's decision shall be final and binding.
- 6. Participants are mandatorily required to keep their identity anonymous during the competition. Disclosure of identity in the form of uniform, badge, bags ,etc. will lead to their disqualification.
- 7. Using mobile phones, smartwatches, or any other reference material by the participants will lead to their disqualification.
- 8. Replacement of any participant of a team is not allowed after registration.
