About the College

The Rohini Kanta Barua Law College was established in the year 1976 as an outcome of a public meeting of the citizens of Dibrugarh held on 20/06/1976 with Shri Pramode Kumar Das, B.L. in the chair as 'Dibrugarh Law College'. The core objective of setting up the institution was 'to create a new avenue at Dibrugarh for imparting legal education'. The College is situated in the heart of the Dibrugarh town, and is permanently affiliated to Dibrugarh University, and approved by the Bar Council of India, New Delhi. On 04/02/1994, the Dibrugarh Law College was renamed as 'Dr. Rohini Kanta Barua Law College' as late Muktalata Barua wife of Dr. Rohini Kanta Barua, a well known name in scientific research of high order and academic excellence donated the land and building (present administrative wing) to the College to commemorate the illustrious name of her husband. Since then, the College has not looked back and has developed the facilities for students one after another as per requirement of the Bar Council of India. Dr. R.K.B. Law College offers a rich environment for studying law and prepares students to enter into legal profession through Three Year LL.B and Five Year Integrated BB.A.,LL.B Programme. Programmes Offered & Eligibility Criteria

LL.B (3 Year) Programme

A three-year LL.B (Bachelor of Laws) program offers a comprehensive understanding of legal principles, systems, and practices. It equips students with critical thinking, analytical skills, and legal knowledge necessary for a career in law. Core subjects include constitutional law, contracts, criminal law, and property law, preparing graduates for diverse legal roles.

Eligibility for LL.B (3 Year) Programme

Admission to LL.B 1st semester class is open to the candidates who have a Bachelor Degree from any University / Institution recognized by University Grant Commission (UGC) with at least 45% marks in major or aggregate. Relaxations up to 5% of total marks in respect of SC/ST candidates and up to 3% in case of OBC/MOBC candidates are allowed as per norms of the Bar Council of India. However the applicants who have obtained 10+2 or graduation/post graduation through open universities system directly without having any basic qualifications for prosecuting such studies are not eligible for admission in law courses. Moreover, the minimum qualifying marks as mentioned above, shall not automatically entitle the candidate to get admission into the college, unless the candidates fulfills other institutional criteria notified by the college at the time of the admission.

Age Limit for LL.B. (3 Year) Course

The Bar Council of India has not imposed any age restriction for pursuing the law degrees.



5 Year Integrated BB.A.,LL.B

A five-year BB.A.,LLB program combines law and business administration, providing students with a thorough understanding of both commercial and legal ideas. It gives students the tools they need to handle challenging legal situations in business settings and gives them a strong foundation in both fields, positioning them for careers in corporate law, consulting, compliance, and entrepreneurship.

Eligibility for 5 Year Integrated BB.A.,LL.B

Admission to BB.A.,LL.B 1st semester class is open to the candidates who have passed HSSLC or Equivalent (10+2 Examination) from any School / College / Institution recognized by Assam Higher Secondary Education Council (AHSEC) or Central Board of Secondary Education (CBSE) with at least 45% marks in aggregate. Relaxations up to 5% of total marks in respect of SC/ST candidates and up to 3% in case of OBC/MOBC candidates are allowed as per norms of the Bar Council of India. However, the applicants who have obtained 10+2 through open school system directly without having any basic qualifications for prosecuting such studies are not eligible for admission in this course. Moreover, the minimum qualifying marks as mentioned above, shall not automatically entitle a person to get admission into the college, unless the candidates fulfills other institutional criteria notified by the college at the time of the admission.

Note:

All decisions with regards to admission shall be taken by the Admission Committee of the College which shall be binding.

Infrastructure Facilities

Administrative Block



The administration of the College is run from the wooden bungalow which was originally residential building of Dr. Rohini Kanta Barua and now it has become one of the heritage building of the Dibrugarh town. The administrative building covers the Principal's office, Vice-Principal's office, Teachers' Common Room, College Office, Internal Quality Assurance Cell and Legal Aid Cell.

Library with Library OPAC and Internet Facilities



The college library is equipped with computer along with internet facilities and photocopy service to the members of the library. It follows open access system and using KOHA software. Book Lending Service has been offered to all library users. Library is administered by the Librarian. Library Development Committee looks into proper administration and development of the college library.

Canteen

The college also provides space for a hygienic canteen for the students. The canteen at present is not functioning due to construction of the new building. However, it will resume once the construction is over.

Old Academic Block



The Old Academic Block of the College is a two storied building which covers three class rooms, one smart classroom, Moot Court Hall and Auditorium of the College.

New Academic Block



The New Academic Block of the College is presently a two storied building which covers one class room, and the library of the College. The expansion of the building is going on which is expected to be completed by August 2025.

Computer Lab



Since law and technology goes hand in hand, so the institution has also arranged for a computer lab for the purpose of practical learning. The students are allowed to use the lab for free whenever required during the college hours.

Conference Hall and Auditorium



The Auditorium of the College was inaugurated on 11th May, 2013 by then DONER Minister Sri Panban Singh Gatowar, in presence of Sri Nogen Saikia, Ex-Chair Person of Axom Sahitya Sabha, District Judge, Dibrugarh, Sri Rumi Phukan, Vice Chancellor of Dibrugarh University and Sri Kandarpa Kumar Deka. The College has a well equipped auditorium with seating capacity of over 200 people which is a regular venue for conference, workshop, seminar etc. The auditorium is also used by the students to exhibit their talents during cultural programmes of the college. In the Auditorium, the College organizes various seminars, workshops, awareness programmes, etc from time to time.

Smart Class Rooms with AC

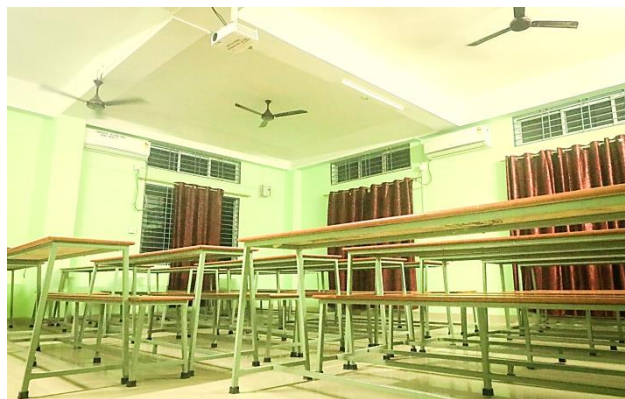


Moot Court Hall



Dr. R.K.B. Law College, provide an exclusive infrastructure for moot court class of the students so that they can acquire excellent practical knowledge.

The institution also has smart classroom facilities. It provides for access to digital board, internet facilities, video conferencing facilities, better audio gadgets, etc. that makes learning interesting and enhances the scope of knowledge by allowing distant experts to interact with the students. The classes are also equipped with ACs considering the comfortability of the students.





Sports Infrastructure

The sports infrastructure is divided into two categories – indoor and outdoor. For indoor sports like carrom, chess, badminton, etc. the college has in-house capacity. And for outdoor sports, the college has entered into a MoU with one of the prestigious institutions of Dibrugarh named D.H.S. Kanoi College for availing the facilities of their playground for all outdoor sports including cricket, football, athletics, etc.

The institution provides for multiple sources of electricity supply including diesel generators, inverters, solar lights, and electricity. The supply of power is continuous within the campus.

Garden

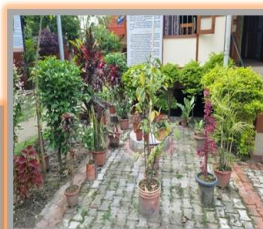
The charm of the college grounds is augmented by a sustainable and eco-friendly garden providing students a peaceful place to relax during their free time.

Committees & Cells

Internal Quality Assurance Cell



With the object to augment quality affirmation practices and to safeguard the exhaustive excellence and academic merit, the college initiated the establishment of IQAC. The IQAC takes feedback from all the stakeholders and analyses it on yearly basis. It has also organised various National & International Seminars in collaboration with ICSSR,

New Delhi & other corporate sectors, FDPs (physical & online mode), Lecture Series on various legal & socio-legal matters wherein professionals and researchers from various reputed institutions have been invited to share their experience & knowledge. Thus, the IQAC looks into the overall development of the college & tries to bring all the initiatives under one umbrella.

Placement Cell

The Placement Cell of the institution has been established for generating placements for the students and arranging campus selection. It also organizes occasional mock interviews for preparing the students for real interview. Recently, the Cell has arranged a campus selection and **three students were appointed** by a renowned Advocate of Dibrugarh.



Moot Court Society



The Moot Court Society is responsible for organizing Moot Court Competitions and training the students on Moot Court and Trial Advocacy. Recently it organized the **Dr. Rohini Kanta Barua Memorial National Moot Court Competition, 2024** with prize money of 1.20 Lakhs INR and other prizes like EBC Reader Subscription, Trophies, etc. NLU Assam won the competition with the School of Excellence in-

Law the Tamil Nadu Ambedkar University became the Runners-up. Former Justice of Gauhati High Court Justice Biplab Kumar Sharma, Former Advocate General Assam Prof. (Dr.) R.C. Barpatragohain, and Secretary Dibrugarh Bar Association Sr. Adv. Satyabrata Sharma were the Judges in the Final Round and around 18 Judges from across the country judged the preliminary, quarter, and the semi finals.

Research and Publication Committee

The Committee is deeply engaged in enhancing research activities and publishing their results as well as conducting events for upgrading the research skills of the Faculties and the Students. Recently, the major event conducted was an Online FDP on Techniques and Methodology for Research in Social Sciences where Resource Persons from different fields and areas like from the Netherlands, the NLUs, the Central Universities etc. delivered their insights. In total more than 100 academicians participated in the FDP. The committee also helps in the publication processes. It publishes quality and international standard books and other periodicals with ISBN, ISSN, ISNI etc. recognitions that are also assigned with Digital Object Identifier (DOI) making them globally accessible.



Legal Advice Cell (Nyayasarthi)



The Legal Advice Cell has been established in the college premises to extend free legal advice and assistance to the under privileged sections of the society. The students of the College, with the assistance of the faculty and practicing lawyers provide free legal advice to the needy people. The Cell also organizes a range of Legal-Awareness Camps and street plays in both rural and urban areas in the vicinity of Dibrugarh District to sensitize masses about various socio-legal issues.

Students' Development Committee

The Committee engages in activities that aims at developing the capacities of the students. It organizes various counselling activities, intra-college competitions, etc. The recent major events conducted by this committee were the N.C. Gohain Memorial Intra-College Wall Magazine Competition and the Dr. Rohini Kanta Barua Memorial Intra-College Debate Competition with cash prizes.



Eco-sense Club



The Eco-sense club is engaged in environmental activities. The major activities include conducting Green Audit, environmental awareness programmes, intra-school art & extempore speech competition, training the students in environmental matters, plantation drive, quality testing of water, air, soil, and adopting eco-friendly products within the college campus. It has successfully made the college campus plastic free and pollution free by adopting sustainable best practices. In addition, the club facilitated the transition of the campus street lighting to solar powered light.

Anti-Ragging Squad and Committee

The Anti-Ragging Squad and Committee is constituted in compliance to the guidelines of the UGC for preventing offences of Ragging. It focuses on creating awareness among the students for preventing ragging activities. Every year during the orientation of each new batch, the committee organizes anti-ragging awareness event in accordance to the guidelines of UGC.



Health and Sanitation Club



Health is an important aspect of modern day human lifestyle. Hence considering the need of proper health and hygiene of the students, this committee plays an important role in building an ecosystem where the health needs of the students are taken care of. The recent activities of this club included conducting a mental health awareness workshop, awareness programme on breast cancer, etc.

Internal Committee

The Internal Committee is constituted in compliance to the UGC regulations for preventing offences of sexual harassment at workplace and gender discrimination. It is focused on initiating events, and activities that primarily consider eliminating gender-based discriminations, and offences. Activities like awareness & counselling programmes on CEDAW, POSCO, Right of Child, Sexual Harassment at workplace has been conducted regularly.



Dr. R.K.B. Law College Students' Union



The Students' Union of the college is constituted after General Elections among the students. This Union allows the students to organize events of their interests and to bring their collective concerns before the college authority. The major events under its responsibility include organizing the annual college week, annual freshers and farewell events, Teachers' Day, Bihu Celebration, Diwali Celebration, and Inter-College Cricket, etc.

Other Committees and Cells

In addition to the above committees, cells and clubs, there are a number of committees that help in the smooth conduct of the daily activities of the college. Some of such committees include:

- **Admission Committee:** This committee takes into consideration matters related to admission of students to the institution each year.
- **Examination Committee:** This committee is focused on conducting examinations and evaluation purposes. It deals with all matters including disciplinary actions for adapting unfair means during examinations.
- **Students 'Grievance Redressal Cell:** It focuses on addressing the grievances of the students through proper mechanisms.
- **ST/SC/OBC/MOBC & Other Minorities Committee:** It is constituted for considering the needs of the minority communities as per UGC Regulations.
- **Library Development Committee:** It is focused on initiatives for development of the library
- **Event Management Committee:** It manages and conducts the events of the college.

Our Associate Institutions

D.H.S.K. College



Dr. R.K.B. Law College entered into a Memorandum of Understanding (MoU) with D.H.S.K. College, Dibrugarh for sharing the field and the auditorium of D.H.S.K. College in return of cooperation in academic activities. Both the neighbouring institutions joined hands together to enhance quality education. Recently the sports activities of Dr. R.K.B. Law College during its college week were held at the field of D.H.S.K. College under this MoU and the Constitution Day celebration was held in the auditorium of Dr. R.K.B. Law College in joint association with the Political Science Department of D.H.S.K. College.

Nowgong Law College and Aequitas Victoria Foundation



Dr. R.K.B. Law College also entered into a MoU jointly with Nowgong Law College and Aequitas Victoria Foundation for establishing the Annual International Journal on Intellectual Property and Corporate Affairs (AIJIPCA) where Nowgong Law College is the Academic Partner and Aequitas Victoria Foundation is the technical partner. In addition to the establishment of the journal and its administration, the MoU also focuses on organizing at least one International or National Conference on IPR and Business Law annually. Till date one National and one International Conferences have been organized under this MoU which have connected the institutions with The Netherlands, United Kingdom, Sri Lanka, and Nepal and has also published an ISBN Book and one volume of the International Journal.

Other Associations

In addition to the above associated institutions and organizations, Dr. R.K.B. Law College has also associated with prominent organizations like **Red Cross Society, Dibrugarh** WITH WHOM ACTIVITIES LIKE Blood Donation Camp and other social welfare activities are conducted and **Senior Citizens' Forum** with whom a number of cultural activities are conducted.



Nowgong Law College



Dr. R.K.B. Law College entered into a Memorandum of Understanding (MoU) with Nowgong Law College, Nagaon, Assam for academic collaboration. Both the institutions have engaged themselves in Faculty Exchange activities that gave the students of both the institutions exposure to the expertise and experience of both the institutions. The major activities jointly conducted by these two institutions include Orientation Programme in Law in hybrid mode, International Conference with funding from OIL India Ltd., FDPs and many more such joint initiatives including journal and books publication for enhancing academic developments.

Nowgong Law College and Kokrajhar Law College



Dr. R.K.B. Law College also has a MoU with Nowgong Law College and Kokrajhar Law College for academic Collaboration. Major events conducted recently under this MoU is the FDP on Research Methodology with Foreign Resource Persons and a Minor Research Project with an approved fund of INR: 1,50,000. An ISBN Book on Multidisciplinary Aspect is also under consideration.

Academic & Extension Activities

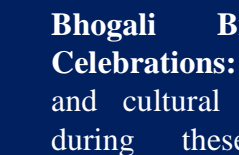
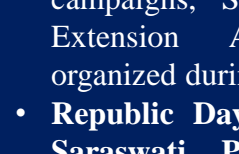
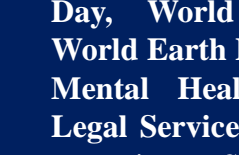
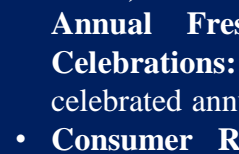
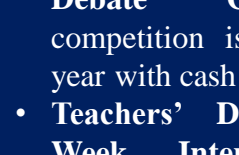
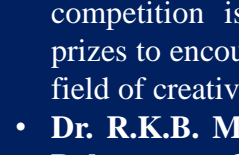
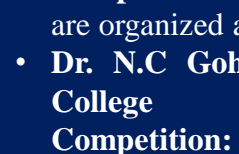
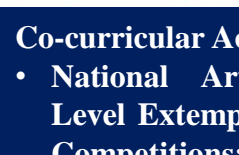

Admission Criteria and Procedure

Procedure for Admission

Admissions to the LL.B and BB.A.,LL.B. Courses are based on merit at the qualifying examination. Intending students are required to submit the online/offline filled up application form along with the requisite documents on or before the date as notified by the College from time to time. After verification of documents and payment of fees on the account of the College at State Bank of India, Dibrugarh Branch located at Thana Chariali, their provisional admission will be confirmed. The student is required to deposit the counterfoil of deposit slip in the College Office to get Admission Receipt from the College. The admission confirmed by the institution are subject to approval of the Dibrugarh University.

To promote cashless economy the College accepts admission and other fee through electronic modes only. The fee for admission is inclusive of admission fee, tuition fee, library fee etc. payable in single installment per annum at the time of admission.

Entrance Examination

The Admission Committee of Dr. R.K.B. Law College may recommend for conducting an entrance examination based on the situation. If such entrance examination is conducted for the purpose of admission, then the cut-off for selection of candidates and the criteria for admission shall be notified in the official website.

Scholarships

The institution also offers scholarship under which the entire admission fees or a part of it may be waived for meritorious students depending upon the need of the student, circumstances and the terms and conditions of the scholarship.

For availing the scholarship, eligible candidates may have to undergo a written examination based on the decision of the admission committee.

Admission Fees and Installment Process

The price of the application form for admission with the hardcopy of the prospectus is INR: 500 (Five Hundred) only.

The admission fees for both the courses is **INR: 39,800 (Thirty Nine Thousand & Eight Hundred) only** inclusive of both the semesters.

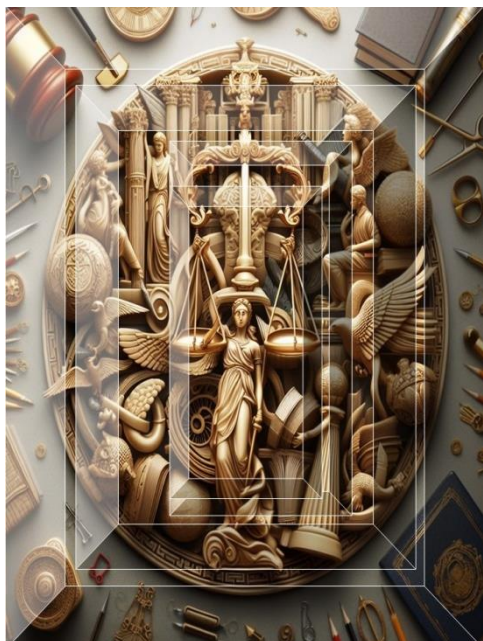

Cancellation of Seats

A Student may forfeit his seat under the following circumstance:

- A student shall forfeit the seat if she/he fails to attend classes without valid ground and permission of the authority for consecutive 15 days from the date of commencement of the classes.
- The name of the student shall also be struck off the rolls if she/ he is admitted to an equivalent course under any other college/institution affiliated to Dibrugarh University during the Academic Session in which she/he is admitted to this College.

- ❖ Students will be required to enroll themselves in the next year classes within 15 days after the completion of their end-semester examination.

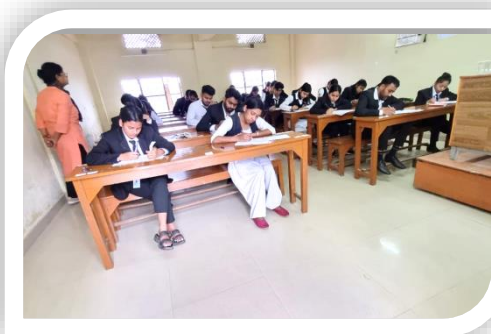
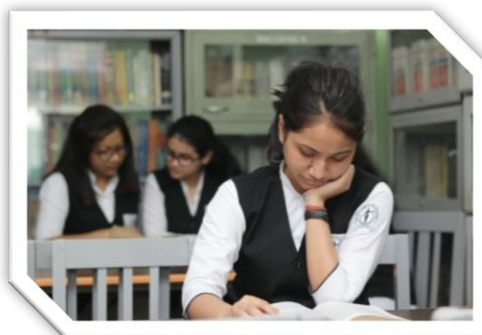
Examination and Evaluation

❖ The scheme of examination shall be of two parts. There will be written End Semester examinations of 80 marks of 3 hour duration out of total 100 marks, as per the Academic Calendar of the University or as notified by the University from time to time.

Remaining 20 marks will be for Internal Assessment to be conducted as follows:

- First Sessional Examination (5 Marks)
- Second Sessional Examination (5 Marks)
- Group Discussion/ Seminar/Assignment (5 Marks)
- Viva-Voce Examination (5 Marks)

❖ There shall be no provision for repeat/betterment in the sessional examination. However, if a student misses any sessional examination for unavoidable reasons, then the concerned teacher may conduct a special examination of his/her subject at her/his own discretion considering the genuineness for absence. Students shall have to compulsorily attend internal assessment, otherwise, they will not be allowed to appear in the End-Semester examination.

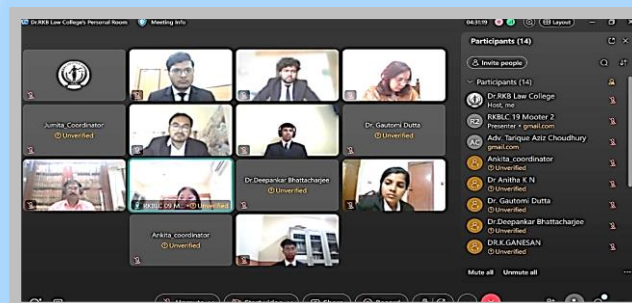

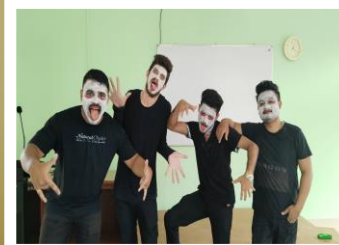
